

It is a misconception shared by many business owners that express entry is the only way for them to immigrate to Canada. However, this stream is limited to young professionals because of the points given according to age.

However, where a foreign investor invests in Canadian business, they create the opportunity for themselves to obtain a work permit, followed by permanent residency. And after being a permanent resident of Canada for the required period, they will be eligible to become citizens.

However, to achieve that, it must be demonstrated that you intend to work as a self-employed individual in Canada and have at least 2 years of experience in your selected profession.

Points are allocated for personal categories such as work experience, age, education, official languages, and adaptability.

## Provincial Nominee Programs

Express entry is the most well known and one of the fastest routes for Canadian Permanent Residency, as most applications are processed within six months. The Express Entry Program is a point-based immigration program for professionals who want to settle in Canada. Depending on your points, if you have a competitive score, you will be issued an Invitation to Apply (ITA) for Permanent Residency in Canada.

The requirements are based upon skilled work experience, language ability, age and education. Securing a valid job offer and proficiency in both English and French can drastically increase ones chances of obtaining an ITA.

Additionally, you might have to show that you have enough funds to settle down in Canada with your family depending on the family size accompanying you to Canada. Lastly, there must be no criminal record or cause of inadmissibility that will prevent the you from being permissible to enter Canada.

If you apply under the express entry program, you can choose to live in any province of Canada, except Quebec. There is a different stream for those who are willing to settle in Quebec.

If a Canadian province or territory nominates you to settle down in that location, then you will be eligible to immigrate to Canada as a Permanent Resident. If you meet all the requirements, you will be issued an Invitation to Apply (ITA). Using the ITA, you can apply for permanent residency, and once the application is approved, you can come to Canada as a Permanent Resident.

It is therefore a great way to immigrate to Canada if you meet the requirements. You can either apply through the Express Entry PNP stream or the non-Express Entry PNP stream.



# Atlantic Immigration Pilot Project (AIPP)

Do you wish to hire an international candidate to employ for a position for which you are unable to find any local talent? Therefore, international candidates must be engaged to best satisfy the requirements of Canadian employers. In this regard, an employer will first obtain an LMIA, with certain exceptions, before an international candidate can start working for them.

The LMIA is a document that an employer in Canada may need to obtain from Employment and Social Development Canada before hiring a foreign worker. This will confirm that the foreign worker is not affecting the employability of Canadian workers or permanent residents. Therefore, when an LMIA is obtained by the employer, the foreign worker can apply for a work permit.

There might be additional steps in the process of obtaining the LMIA depending on your circumstances and the industry in which the job is being offered. 




# Family Sponsorship for Parents and Grandparents

If you are a Citizen or permanent resident of Canada, and you meet all the requirements, then you can sponsor your parents and grandparents to become permanent residents of Canada. The first step of the process begins with the submission of an interest to sponsor. If you are invited to apply then you will need to submit two applications: the sponsorship application, and the permanent residence application.

If both are approved, then an agreement will need to be signed which is effective from the day your sponsored family member becomes permanent resident of Canada.

This means your family members can live, study, and work in Canada if they become permanent residents of Canada. The Canadian government believes in uniting families and prioritize this type of applications.
